EVALUATION CRITERIA: The course is graded A to E. **Computer problems** under any circumstances will NOT excuse a late paper or assignment. Course grades will be based on the following:

(a) Exams (100 points): Two exams will be given over the course of the semester, and they will include ONLY multiple-choice questions. Tests will be based on materials covered in class and from the textbook. Exams will be available on canvas during the class meeting time on the day they are scheduled. Exams will utilize honor lock system to ensure students are working individually, but the exams will be open-note (both electronic and non-electronic notes). However, quizlet, chegg, looking up questions on google etc. will not be allowed. The final is NOT cumulative.

(b) DSM-V Diagnosis Paper (30 points)

- 1. Find a fictional character from a movie, book, or TV show that meets criteria for one or more psychological disorders in the DSM V
- Using this character, write 4 MAXIMUM 5 pages (anything over will be deducted points), double-spaced, using times new roman size 12 font, and 1-inch page margins (excluding references), double-spaced, using times new roman size 12 font, and 1-inch page margins
- 3. A more detailed rubric will be available on canvas. A general outline of what I am looking for:
 - *i*. A brief biography of the character.
 - *ii.* A current understanding of what is going on in the character's life.
 - *iii.* The symptoms the character is exhibiting.

- *iv.* A summary of the DSM-V diagnosis(es) that have specified criteria met from these symptoms.
- v. Prognosis and treatment recommendations using APA style references

(c) Psychology Book Club (30 points)

- 1. The thirteen trade books listed earlier in the syllabus all cover psychopathologyrelated topics. Some present cutting-edge, controversial ideas. Others are critically-acclaimed personal memoirs, designed to pull readers into the bona fide phenomenological experience of someone living with a "mental disorder." I ask that you pick one (just one!) of the thirteen books listed at the beginning of the syllabus to read as we move through the semester. It's up to you to read your trade book at your own pace during the semester. You can get started on this right away if you choose. When you are done, you will be asked to write an Amazonesque review of the book.
- 2. This is not a book report, and thus there is no rubric! This assignment is meant to be a reflection of your thoughts about the book's content and your reactions to the material. I will never test your memory on your book's content. Still, this is a class assignment and proper grammar, punctuation, formatting, and attention to detail is expected. I recommend cracking open your book of choice no later than a month before the due date in order to avoid intense anxiety the night before it is due.
- 3. Write a minimum of one page (maximum two pages), double-spaced, using times new roman size 12 font, and 1 inch page margins.
- 4. Further instructions/rubric will be provided in canvas.
- (d) Psychology Research Experience (20 points):
 - 1. Option 1: Participate in Research Experiments
 - i. Taking part in the Department of Psychology Participant Pool allows students to directly experience ongoing psychological research. For this option, you will complete 20 credits (10 hours) of participation in psychological research studies. Important: If you are a residential student then you will only be able to earn a certain amount of your credits via online studies. We will notify you of the exact amount on SONA once we have calculated the number of online studies we have. The remaining credits must be completed by participating in studies in the lab.
 - ii. When you complete the research experience, you will receive points that are added into your final grade. If you do NOT complete the full number of credits by the deadline, you will receive points at a rate of 1 point per credit completed.
 - iii. You must be at least 18 years old to complete Option 1. If you are not 18 years old you must complete Option 2. Students who will turn 18 during the semester may choose to complete Option 1 after their birthday but are strongly encouraged to complete Option 2 to ensure they complete the research requirement.
 - iv. Further instructions/rubric will be provided in canvas.
 - 2. Option 2: Critical Analysis Papers
 - i. Participating in research is a valuable component of understanding the science of psychology. However, students who prefer not to participate in

research or do not meet the requirements for selecting Option 1 can select Option 2 as an alternative.

- ii. For this option, you must read 4 scientific research articles from the approved list of peer-reviewed professional journals in the area of psychological science. You must submit 1 critical analysis paper per scientific article (4 papers total).
- iii. Further instructions/rubric will be provided in canvas.
- (e) **Psychology Research Experience Check-In (5 points):** Please complete the Canvas assignment by March 22nd to let me know if you will be choosing option 1 or 2 by either submitting a screenshot of your active SONA account or verifying your intent to complete the Critical Analysis Papers.
- (f) Get to Know Me Survey (5 points): Answer some questions to help me get to know you and your interests a bit better!
- (g) In-Class Activity/Attendance (60 points): Participating in course activities and attending lectures will count toward your grade. 12 lectures at 5 points each total 60 points toward your final grade.
 - 1. If you cannot attend an in-class assignment due to a University approved reason (e.g., illness, religious reasons, emergency, etc.), you may earn points for the day by writing a 100-250 word paper on your reactions to the chapter(s). Please coordinate make-up assignments with me.

GRADING SCALE

For all work except exams, you will receive a 10% grade reduction each day an assignment is late (e.g., 1 minute late to 23 hours and 59 minutes late is 10% off). Once 96 hours have passed since the assignment was due, you will receive a 0. If there is an extenuating circumstance (including sickness, death of a close friend or family member, mental health issues, etc) please contact me immediately so we can figure out an appropriate new due date. Documentation must be provided. Here is an example:
