Course Information

Social and Behavioral Sciences General Education Subject Area Objectives

Social and behavioral science courses provide instruction in the history, key themes, principles, terminology, and underlying theory or methodologies used in the social and behavioral sciences. Students will learn to identify, describe and explain social institutions, structures or processes. These courses emphasize the effective application of accepted problem-solving techniques. Students will apply formal and informal qualitative or quantitative analysis to examine the processes and means by which individuals make personal and group decisions, as well as the evaluation of opinions, outcomes or human behavior. Students are expected to assess and analyze ethical perspectives in individual and societal decisions.

Course Overview

This course is an overview of major topics in modern psychology, the scientific study of behavior, and mental processes. As a first course in the discipline of psychology, it introduces some of the fundamental concepts, principles, and theories with a consideration for the complexity of human behavior.

- 1) To teach you the science behind psychology and how it differs from the media's interpretation.
- 2) To provide you with an introduction to the different areas within the field of psychology.
- 3) To teach you the concepts in the field and how to apply them.

 - ❖ How can you turn the basic question of, "Why do Gator fans do the chomp during football games?" into a scientific investigation?
- 2) Develop yourself as a critical consumer of information.
 - ❖ When reading a news article or reviewing research findings, are you able to "look beyond what you see" (Lion King...)? Does the news reporter have biases that may influence the presentation of the information? Did the researchers consider "third variables" that may account for the findings? Have you considered your own biases and if you are "cherry-picking" for evidence?
- 3) Compare and evaluate the various theories that provide explanations for why a given phenomenon may occur.
 - ❖ According to different theories of personality, what are some factors that may influence personality development in individuals? Can personality development be attributed to cognitive, psychosocial, and morality changes?

Late Work and Make ups:

You look at the clock and now there is only 20 minutes before the deadline so you don’t even have time go to a local Starbucks to access the internet. So you email me panicked, telling me about this horrible situation and plead for me to allow you to take the quiz late. Well unfortunately, unlike Lloyd Christmas who famously said “So you're telling me there's a chance. YEAH!”, you have NO chance of earning points for late work so please make sure you turn your assignments in on time. So please, please, please, please be responsible and make sure you do not wait until the last minute to do any of your graded assignments. Of note, if the Canvas website experiences course wide technical difficulties deadlines will be adjusted to allow for completion of assignments.

NO MAKE-UPS WILL BE GIVEN ON ANY MATERIAL FOR THIS COURSE, except for university excused absences with adequate documentation (i.e. doctor’s note). You must notify me before the course material is due unless there are extenuating circumstances that physically prevent you from doing so. Doctor’s notes etc. must be provided prior to making up the missed assignment. Lastly, make-ups need to be completed no later than a week after the material was due (including weekends and holidays). Thus, if the material was due on Wednesday, then it must be completed by the following Wednesday unless there are significant extenuating circumstances. **Keep in mind that for assignments that are open for multiple days make-ups will only be allowed if the documentation for the university approved absence is for more than 50% of the assignment window. Grade Disputes

For all graded assignments, you will have 1 week from the day your grades are released to dispute your grade, after which your grade will become final and can no longer be disputed. Obviously, just because you dispute your grade DOES NOT mean your grade will be changed in your favor. VERY IMPORTANT, keep in mind that if you request me to reevaluate your grade on an assignment, I will have to regrade your assignment which means your grade could increase, stay the same, or decrease based on my evaluation. Also, this should not be a default reaction to any low grade you receive, please only pursue this route when you are confident that you can make a case that an error occurred. If you wish to dispute a grade you must email me to inform me that you wish to dispute your grade. Then you must attend office hours and be ready to provide a sound argument using the rubric and course material to support your claim. Lastly, any changes to grades will be made solely at the discretion of your professor.

To be clear, if you submit any work to this class for grading, that has been generated (in part or in whole) using any kind of AI program/computer program/chatbot/etc, under the guise that it is your OWN original work, then you will have committed academic misconduct and you will be reported to the university. Remember, **any form of academic misconduct within this class will result in a course grade penalty of one letter grade and completion of a plagiarism/ethical decision making course. However, if you have a prior history of misconduct then plagiarism/misconduct on any assignment will result in an E grade in the course.** The two greatest threats to the academic integrity of the University of Florida are cheating and plagiarism. Students should be aware of their faculty's policy on collaboration, should understand how to properly cite sources, and should not give nor receive an improper academic advantage in any manner through any medium. In-Class Recording

Grading

Exams (200 points total)

There will be *four* non-cumulative exams (worth 50 points each) consisting of multiple-choice questions. The exams will be based on the lecture and book material. On exam days, arrive on time and bring a number 2 pencil with you. If you arrive after the first person has turned in his/her exam, you *will not* be allowed to take the exam. You are responsible for bringing a pencil. Each exam must be completed as scheduled unless you provide *documentation* of a serious illness, death in the family, or other *serious emergency* that *prevents you from being present on the day of the exam. Make-up exams will not be administered under any other circumstances. Please read above section on Make-up work carefully.*

Assignments (40 points total)

There will be 4 assignments over the semester. The details of the assignments will be posted on Canvas. These assignments must be completed independently; any collaboration between students is not permitted and is a violation of the UF Honor Code. Please make sure you read the above section discussing academic misconduct. The assignments must be typed in APA format and submitted electronically via Canvas. Assignments must be submitted on the due date indicated in the syllabus and should be turned in using the .doc or .docx file formats.

Experimental Participation Requirement (10 points)

SONA Participation Pool: Learning about Psychology requires reading, listening, and doing. As a supplement to lecture, you are required to participate in 10 hours of experimental research studies, or to complete an equivalent alternate assignment (see assignment on CANVAS for more details). There is a Psychology Department requirement that all students enrolled in Gen Psych, Personal Growth, or any 3000 level class participate in the SONA participation pool. Please see the CANVAS assignment for very detailed instructions about this assignment. There is also a file uploaded to CANVAS called “SONA Participation Pool”. The deadlines for this requirement will be posted on the research requirement document by the second week of class. Completion of this requirement affects your course grade based on the amount of research credits you earn. Do NOT wait until the last minute to complete this requirement. The longer you wait the harder it will be to get all the credits need! When you complete the research experience, you will receive 10 points that are added into your final grade. If you do NOT complete the full number of credits by the deadline, you will receive points at a rate of 1 point per credit completed.
