Course Outline

Social and Behavioral Sciences General Education Subject Area Objectives

Social and behavioral science courses provide instruction in the history, key themes, principles, terminology, and underlying theory or methodologies used in the social and behavioral sciences. Students will learn to identify, describe, and explain social institutions, structures, or processes. These courses emphasize the effective application of accepted problem-solving techniques. Students will apply formal and informal qualitative or quantitative analysis to examine the processes and means by which individuals make personal and group decisions, as well as the evaluation of opinions, outcomes, or human behavior. Students are expected to assess and analyze ethical perspectives in individual and societal decisions.

Course Overview

This course is an overview of major topics in modern psychology, the scientific study of behavior, and mental processes. As a first course in the discipline of psychology, it introduces some of the field's fundamental concepts, principles, and theories with a consideration for the complexity of human behavior.



Course Goals

- 1. To teach you the science behind psychology and how it differs from the media's interpretation.
- 2. To provide you with an introduction to the different areas within the field of psychology.
- 3. To teach you the concepts in the field and how to apply them.



Course Objectives

By the end of this course, students will be able to:

- 1. describe a variety of major theories, topics, and issues in psychology.
- 2. identify the key roles that psychology plays in our everyday lives.
- 3. gain understanding of the scientific methods as applied to psychological research
- 4. gain understanding of human behavior, emotion, and mental processes
- 5. apply psychological knowledge to the real world in problem solving
- 6. evaluate and synthesize psychological knowledge with critical thinking

Course Requirements



Quizzes and Exams

This class has four (4) non-cumulative exams. Each exam consists of 50 multiple-choice questions and is worth 50 points (1 point per question). Exams are based on lecture and textbook content, and are designed to assess your understanding of the course material and ability to apply it. We also have a 5-point multiple-choice syllabus quiz that will be available for the first 1.5 weeks of the semester.

All exams are closed book and closed notes, and you will need a #2 pencil for the scantron sheet. Your lowest exam grade will be dropped from your overall grade; thus, <u>only three (3) exam scores</u> will be included in your final grade.



Writing/Project Assignments

This class has three (3) writing/project assignments for students to complete individually outside of class: Creating an original optical illusion (20 points), an Implicit Association Test (IAT) reflection (10 points), and a reflection paper about a contemporary news article related to psychological science (30 points). Grading rubrics and additional assignment details are available on Canvas, and will also be covered by the instructor during class.



SONA Research Participation Requirement

The Psychology Department requires that all students enrolled in PSY2012 participate in research. The deadlines for this requirement can be found in the document titled "SONA Research Requirement Instructions" (on our Canvas home page). Please note: the deadline to participate in research studies is *earlier* than the deadline to assign credits to this course. Completion of this requirement affects your course grade based on the amount of research credits you earn. Do **NOT** wait until the last minute to complete this requirement. The

longer you wait, the harder it will be to get all the credits needed! If you are unable to participate in SONA research due to age or simply do not wish to participate in research studies, you may "opt in" to an alternative assignment.
