Description

This is a course on research methods and applications in behavior analysis. You will choose a BA faculty member and/or graduate student(s) with whom you will work directly. The specific activities vary from semester to semester, and from lab to lab. During week 1, you should contact the specific professor or graduate student(s) with whom you have been approved to conduct the research activities. Be sure to fill out the 4911-Research Form, and indicate Behavior Analysis under "area."

Objectives: By the end of the semester, students will be able to:

Perform research tasks, including but not limited to collecting data, calculating interobserver agreement, literature reviews, and graphing.

Text

There is not a specific textbook, but your lab will most likely recommend or assign readings related to the research projects.

Lab Meetings

These are variable, but most labs meet once per week. Your attendance at research meetings is arranged between you and your lab supervisors.

Lab Activities

These are variable, but most labs have activity several times per week if not daily, depending on the specific lab with which you are doing work. Your specific activities will be assigned by your research supervisors.
